Dispute Resolution

Acting as an attorney on the Supreme Court's retrial protest case of the construction contract dispute between Yingkou Economic and Technological Development Zone Jincheng Technology & Trade Co., Ltd. and Dalian Zhongyi Construction Group Co., Ltd.: the first instance of this dispute occurred in 2002, and during 18 years, the requests of Yingkou Jincheng Company to Bayuquan Court, Yingkou Intermediate People's Court and Liaoning High People's Court for the first-instance, second-instance and retrial were not supported. Under this circumstance, Chen represented Yingkou Jincheng Company to participate in the retrial protest stage of the case, and provided professional legal research and services for Yingkou Jincheng Company from the aspects of sorting out the evidence and summarizing the reasons for the protest. Finally, he won the winning judgment of the Supreme Court and won the rights for the clients.
